### **Ineligible players**

Witney 2, Cowley 2, Cowley 4 and Banbury 3 all suffered match-point penalties after accidentally fielding an ineligible player. For Witney 2, Cowley 2 and Cowley 4 the ineligibility was caused by playing for another team in the same division. Following a similar breach last year, the clubs that could have been caught by this rule were alerted at the start of the season.

In the **Frank Wood Shield**, teams from Didcot and Oxford University each inadvertently fielded a player who had played fewer than two league matches for the club and so was ineligible for the FWS. In both cases this cost the team a place in the next round.

#### **Requests for postponements**

Several requests were received, none of them truly in accordance with the *force majeure* provision in the Rules. No objections from the Secretary provided that both captains agreed, but in each case the captain receiving the request was advised that he/she could legitimately insist, without feeling guilty, that the match was played on the appointed date.
